UNDP Project Support Office (PSO) in Russia is implementing the UNDP-GEF project "Integrated Natural Resource Management in the Baikal Basin Transboundary Ecosystem" (UNOPS execution modality) and the UNDP/Coca-Cola project "Every Drop Matters: Lake Baikal" (PSO execution). The "Every Drop Matters: Lake Baikal" project funds constitute co-financing to the UNDP-GEF "Integrated Natural Resource Management in the Baikal Basin Transboundary Ecosystem" project.

UNDP and UNOPS have similar procurement procedures for goods. Therefore, and in order to provide for efficient procurement and avoid extra transaction costs the two projects are jointly organizing and co-financing this service.

  - (d) Suppliers have been declared ineligible by the World Bank.

Furthermore, as a condition of doing business with UNOPS it is necessary that suppliers, their subsidiaries, agents, intermediaries and principals cooperate with the Office of Internal Oversight Services (OIOS) of the United Nations, UNOPS Internal Audit and Investigations Group (IAIG) as well as with other investigations authorized by the Executive Director and with the UNOPS Ethics Officer (during preliminary reviews in line with UNOPS whistle

#### **Background:**

The project's objective is to spearhead integrated natural resource management of Baikal Lake Basin and Hovsgol Lake ensuring ecosystem resilience, reduced water quality threats in the context of sustainable economic development. The project has three primary components: elaborating a strategic policy and planning framework; strengthening institutional capacity for IWRM; and demonstrating water quality and biodiversity mainstreaming practice, including groundwater monitoring and protection.

This project builds upon a solid, decades-old baseline of bilateral cooperation between Russia and Mongolia on the transboundary waters of the Selenga River and by extension the Baikal Basin itself. To date, international support for environmental conservation and management in the Baikal Basin has not been transboundary in orientation; little support has been provided the two countries in strengthening their transboundary cooperation to manage sustainably the globally significant environmental benefits represented by the incomparable Lake Baikal and its transboundary Basin, at the top of which lies Mongolia's aquatic jewel, Lake Hovsgol. In addition to this solid baseline of transboundary cooperation are two rapidly growing economic baselines in mining and tourism, with mining being the biggest and fastest growing economic activity in the Baikal Basin and tourism a smaller but also rapidly growing sector in both the Russian and Mongolian portions of the Baikal Basin. Both of these sectors hold much promise in becoming better stewards of the Baikal Basin's aquatic ecosystems. In the absence of a GEF investment, these barriers are likely to continue hampering an effective transboundary response to the critical threats that are already impacting the ecosystem health and resilience of the Baikal Basin.

Successful implementation of a regional project like "Integrated Natural Resource Management in the Baikal Basin Transboundary Ecosystem", to a large degree depends on effective implementation and ownership of project-inspired work at the national and local levels.

#### Justification of consultancy:

Lake Baikal and its transboundary basin including Lake Hovsgol represent an unparalleled global benefit in terms of international waters and biodiversity values. While past and current efforts to protect and sustainably utilize the environment and its natural resources are impressive,



they are insufficient to the task of addressing the threats to the health of the Baikal Basin's interconnected aquatic ecosystems. These threats include: climate change, pollution and sedimentation, nutrient loading, and habitat destruction. To address these threats successfully conservation work must move beyond the protected area limits and into the 87% of the Basin that is not protected where natural resource exploitation continues without regard to ecosystem health and biodiversity conservation objectives. Significant barriers hamper both countries' ability to move ahead both within their national envelopes and jointly on a robust transboundary level. These barriers include: policy and regulatory gaps, institutional weaknesses, poor utilization of BAT/BEP relevant to key issues facing the Basin, and low levels of awareness of transboundary BB issues.

Overall, the basic legal and policy frameworks for the conservation and sustainable management of the Baikal Basin are in place. From a transboundary perspective, lacking are specific laws or policies enabling the transboundary monitoring of aquatic ecosystem health both in Russia and Mongolia. The regulatory basis for ecosystem conservation and water-pollution prevention in Baikal has not yet been completed. For example, the regulatory and policy mechanisms needed to implement a SAP, as well as sub-basin watershed management plans are as yet uncertain. Several scientific components for SAP development and implementation remain yet to be completed, particularly with regard to the extent of groundwater / surface water interconnectivity in the region, especially along the Selenga River; and accumulation of persistent organic pollutants in the benthic sediments and biota of the Basin's rivers, deltas and lakes. Neither Russian or Mongolian law adequately stipulates clear and practical environmental quality standards for ground water and surface water. The two are inextricably linked in most river systems. The picture of water quality threats from industrial and mining sites remains incomplete; and measures on how best to handle residual pollution problems from abandoned mining sites have not been defined in policies on either side of the border. EIA procedures do not properly address biodiversity risks; and sectoral programs are operating without standards for minimization or reduction of impacts to biodiversity. Tourism laws and policies focus more upon the economic aspects of tourism development and promotion and give short shrift to detailing guidelines and training on mainstreaming biodiversity and ecosystem health management objectives into tourism planning and management practices, including utilizing new tools such as certification incentives for environmentally sustainable behavior by tourism operators.

None of the existing bodies set up at bilateral and national levels (the Joint Task Force, and the Baikal Commission in Russia) have the authority, budget and cooperative framework necessary to reduce threats / barriers to water quality and biodiversity objectives.

The EIA process does not adequately address biodiversity conservation considerations. Even though Russia has established national procedures for assessing environmental impacts of economic projects, or any other activity that may have direct or indirect impacts on the environment, and biodiversity is an obligatory part of EIA content, there are still some barriers to fully integrating biodiversity conservation considerations into all phases of mining and tourism sector investment projects.

Obstacles to capacity building among involved stakeholders relates in part to peculiarities of public "environmental" awareness in the region.

#### **Development objective:**

Public education is the key element for enhanced public awareness of the conditions, challenges and threats to the environment of the Baikal Basin. Adequate education is relevant to



all concerned stakeholders at all levels in the civil society. This activity will aim at ensuring and improving the availability of regular comprehensive reports providing accurate, up-to-date and accessible information about environmental conditions of the Baikal Basin and thereby enhancing the consciousness of the civil society.

Lake Baikal is a global symbol of clean water resources, its strategic location, its potential for tourism development as well as its status as a natural heritage site will enable this work to raise awareness and knowledge about sustainable water use and waste management among the local population and tourists through hands-on, service oriented actions such as cleaning up litter clogged riparian zones. Project messages will encourage the preservation and sustainable use of Lake Baikal's natural resources by local communities and will promote educational work targeted at local communities and wider local audience, including tourists, mass media, and business. Because of the high profile of Lake Baikal and its global significance it can become a symbol for a national water conservation campaign beyond the local and regional context. Therefore, the project will also support a nation-wide public awareness programme targeting specific groups for results-based awareness raising initiatives.

An ecological learning kit "Baikal treasure" was designed in the frameworks of joint UNDP/Coca-Cola Co. project "Every drop matters: Lake Baikal" and serves as an impulse to both Baikal region scientists' and teachers' innovation findings and also attracts interest of teachers, schoolchildren and their parents.

#### **Immediate objective(s):**

To develop a conception and to organize the training workshop "Environmental education on lakeside areas: best practices and innovations" for the purpose of:

- Presentation of the new ecological learning kit "Baikal treasure" to international community in English;
- Learning exchange and analyses of the educational process of the learning kit "Baikal treasure" in Russian;
- Discussion of usage of innovation approaches in education for sustainable development;
- Evaluation of joint experience in the environmental education on lakeside areas;
- Development of recommendations for the environmental educational projects implementation in the Baikal region.

In the frameworks of this consultancy the following activities should be implemented:

- To develop a conception and to organize the educational training workshop. Accommodation, meal and transportation should be provided the main participants (~40 attendees);
- To get involved in the training workshop a broad spectrum of local and foreign representatives of ecological organizations, including educational, ecological bodies and NGOs, state owned organizations, scientists, specialists of protected areas and mass-media.
- To provide and informational support of all events (websites, mass-media, local TV channels);
- To develop recommendations on implementation of ecological educational practices in the Baikal region;



• To prepare the workshop collected articles.

#### **Expected Outputs, reports and related logistics:**

The payment will be done in 3 installments, based on necessary reports and Project Manager's signature according to the following schedule:

- **20% payment** payment as a first installment upon the submission of detailed calendar plan for activities to be carried out within the framework of the consultancy, no later than first 7 working days.
- **50% payment** remaining payment upon providing a workshop conception and program, no later than 15 June 2014.
- **30% payment** remaining payment upon providing: 1) report on holding of training workshop; 2) recommendations on ecological educational practices implementation; 3) the workshop collected articles, no later than 30 September 2013.

**Budget:** An indicative cost of USD 20,000 has been estimated for this service (USD 9,000 – UNDP, USD 11,000 - UNOPS)

Учебно-методический комплект «Байкальский сундучок» был разработан в рамках проекта ПРООН/Кока-кола «Каждая капля имеет значение: озеро Байкал», и служит новым импульсом инновационным поискам ученых и педагогов бассейна озера Байкал и пользуется интересом и поддержкой со стороны педагогов-практиков, учащихся и родителей.

#### Задачи:

Разработать концепцию и организовать семинар-мастерскую «Экологическое образование на приозерных территориях: практический опыт и инновационные технологии», целью которого являются:

- презентация международной общественности комплекта нового учебного издания «Байкальский сундучок» на английском языке;
- обмен опытом и анализ перспектив использования учебного издания «Байкальский сундучок» на русском языке;
- обсуждение вопросов инновационных подходов в сфере образования для устойчивого развития;
- оценка опыта сотрудничества в сфере экологического образования на приозерных территориях;
- выработка ближайших перспектив в реализации эколого-образовательных проектов в Байкальском регионе.



В рамках данной работы необходимо выполнить:

- Разработать рекомендации по применению экологических образовательных практик в Байкальском регионе.
- Подготовить сборник материалов семинара.

**2-Damage to Persons and Property** The Contractor shall indemnify and hold harmless UNOPS, its officers, agents, employees and servants from and against all suits, claims, demands, proceedings, and liability of any nature or kind, including costs and expenses, for injuries or damages to any person or any property whatsoever which may arise out of or in consequence of acts or omissions of the Contractor or its agents, employees, servants or subcontractors in the execution of this Contract.

<u>4-Confidentiality</u> All maps, drawings, plans, reports, documents and all other data compiled by or received by the Contractor under the Contract shall be the property of UNOPS, shall be treated as confidential and shall be delivered only to the duly authorized representative of UNOPS upon completion of the Services.

Upon termination of this Contract, the Contractor shall take immediate steps to terminate his performance of the Contract in a prompt and orderly manner and to reduce losses and to keep further expenditures to a minimum. Unless such termination has been occasioned by the Contractor's breach of this Contract, the Contractor shall be entitled to be paid for the part of the Services satisfactorily completed as of the date of termination, plus substantiated costs resulting from commitments entered into prior to the date of termination as well as any reasonable substantiated direct costs incurred by the Contractor as a result of the termination, but shall not be entitled to receive any other or further payment or damages.

<u>9-Privileges and Immunities</u> Nothing in or relating to this Contract shall be deemed a waiver of any of the privileges and immunities of the United Nations of which the UNOPS is an integral part.

**10-Settlement of Disputes** Any controversy or claim arising out of or in connection with provision of this Contract or any breach thereof, shall, unless resolved through direct negotiation, be settled in accordance with the UNCITRAL Arbitration Rules then in force.
