#### **Background:**

The project’s objective is to spearhead integrated natural resource management of Baikal Lake Basin and Khovsgol Lake ensuring ecosystem resilience, reduced water quality threats in the context of sustainable economic development. The project has three primary components: elaborating a strategic policy and planning framework; strengthening institutional capacity for IWRM; and demonstrating water quality and biodiversity mainstreaming practice, including groundwater monitoring and protection.

This project builds upon a solid, decades-old baseline of bilateral cooperation between Russia and Mongolia on the transboundary waters of the Selenga River and by extension the Baikal Basin itself. To date, international support for environmental conservation and management in the Baikal Basin has not been transboundary in orientation; little support has been provided the two countries in strengthening their transboundary cooperation to manage sustainably the globally significant environmental benefits represented by the incomparable Lake Baikal and its transboundary Basin, at the top of which lies Mongolia’s aquatic jewel, Lake Khovsgol. In addition to this solid baseline of transboundary cooperation are two rapidly growing economic baselines in mining and tourism, with mining being the biggest and fastest growing economic activity in the Baikal Basin and tourism a smaller but also rapidly growing sector in both the Russian and Mongolian portions of the Baikal Basin. Both of these sectors hold much promise in becoming better stewards of the Baikal Basin’s aquatic ecosystems. In the absence of a GEF investment, these barriers are likely to continue hampering an effective transboundary response to the critical threats that are already impacting the ecosystem health and resilience of the Baikal Basin.

Successful implementation of a regional project like “Integrated Natural Resource Management in the Baikal Basin Transboundary Ecosystem”, to a large degree depends on effective implementation and ownership of project-inspired work at the national and local levels.

#### **Justification of consultancy:**

Baikalsky, Baikalo-Lensky and Barguzinsky protected areas (PA) in Russia’s Baikal Basin are receiving large investment from the government for tourism development. This PA will receive over \$13 million from the MNRE in 2011-2013 for tourism development. In addition a regional Baikal investment programme has been developed with a large tourism development component focused on Buryatia.

This output will provide incremental assistance in shaping investments to maximize the mainstreaming of biodiversity and ecosystem health objectives and practices into tourism development. Biodiversity-compatible tourism plans has to be developed and adopted. Russian plans will be designed specifically to inform decision-making. Project resources will also support the development of model public-private contracts for these PA to use that incorporate these clear principles and requirements for “eco-tourism” at the planning and operational stages of tourism enterprises. The "Baikal Special Economic Zone of Tourism and Recreation" regulation and plan will be served as the entry point for mainstreaming activities under this output. Practical guidelines and principles appropriate to the Baikal context will be promulgated. PA staff, tourism operators and tourism policy makers will be trained as part of the pilot.

Each park and protected area needs a plan that describes how tourism and associated development will be managed. The plan represents the desired future state or condition of the protected area and the most efficient and equitable path to that future. Such a plan details the specific goals and objectives mandated for the area in its founding legislation, decree or government policy, describes the objectives for tourism development, and specifies the management actions, budgeting, financing and park zoning needed to achieve those goals. In a sense, park plans for managing tourism attempt to maximize the benefits of tourism while minimizing its costs. Tourism policies are an important component of the overall document, sometimes called a management plan.

It is important in designing a planning process to adopt a procedure that is understandable, defensible, where decisions can be traced and where the value judgments inherent in protected area planning are made explicit. Most of all, it is essential that all stakeholders are appropriately involved in the process. Making management decisions about tourism in protected areas is not easy; it involves not only protected area managers but also affected citizens, including the local public, visitors, private operators and scientists. To ensure that each group can contribute its different type of knowledge to decision making, it is essential to establish a public involvement programme, which may be modest or comprehensive, depending upon the needs.

### **Development objective:**

This work is carried out under Component 3.3 for the "Zapovednoe Pribaikalye" which consists of Baikalo-Lensky Protected Area and Pribaikalski National Park. The purpose of this service is to include biodiversity and ecosystem health management objectives into tourism planning and practice, to create the conditions for ecotourism development in the reserve, compatible with biodiversity.

Khoboi Cape – is a unique tourist place on Olkhon Island, Lake Baikal within the territory of Pribaikalski National Park. It needs an accomplishment of eco-trail, which should be marked with signs (e.g. flags) for safe walking (there is a dropoff).

The service will develop a biodiversity compatible ecotourism plan and accomplish of eco-trail through the Khoboi Cape, installation of viewing platforms and informational signs.

Additionally a reservation zone in Khankhoiskaya Bank for preservation of population of rare plant *Craniospermum subvillosum* *Lehm.* should be created.

This plant is included into the Red List of Irkutsk oblast (2010). This species is vulnerable due to tightness of ecological conditions and extreme anthropogenic load. The population is extremely damaged by wheels of vehicles, moving through the tongue of sand. The tongue is one of still surviving populations of the plant and an appropriate object for creation of a reservation for preservation of it population. Transport traffic ban through the tongue of sand and prohibition of camps and parkings will create the conditions for maintenance of magnitude of the population.

### **Immediate objective(s):**

It should be necessary to implement in the frameworks on consultancy:

- Perform a reconnaissance of the ecological trail in Khoboi Cape and the reservation zone on Khankhoiskaya Bank.
- Develop the concept of the eco-trail and biodiversity compatible eco-tourism plan for visiting Khoboi Cape.
- Develop the plan of the reservation zone in Khankhoiskaya Bank.
- Setup the reservation zone in Khankhoiskaya Bank (installation of barriers for transport traffic ban and creation of foot path eco-trail through Khankhoiskaya Bank).
- Construct the eco-trail in Khoboi Cape with wooden viewing platforms.
- Develop and produce information signs for the tourist route using the standards of publications of UNDP-GEF (the logos will be provided by Project Management Unit (PMU), the layout should be agreed with the PMU).

**Specific Deliverables:**

The service is expected to deliver the following:

- The eco-tourism plan for visiting Khoboi Cape.
- The plan of the reservation zone for Khankhoiskaya Bank.
- The reservation zone in Khankhoiskaya Bank.
- The eco-trail in Khoboi Cape with wooden viewing platforms.
- Information materials for both eco-trails.

### Приблизительный перевод на русский язык:

#### Цель:

Данная работа выполняется в рамках компонента 3.3 для «Заповедного Прибайкалья», которое состоит из Байкало-Ленской охраняемой территории и Прибайкальского национального парка. Цель настоящей работы состоит во включении элементов управления здоровьем экосистем и биоразнообразием в планирование организацией туризма, создание условий для развития экотуризма в заповеднике, совместимого с биоразнообразием.

Мыс Хобой – уникальное туристическое место на острове Ольхон (озеро Байкал), в пределах территории Прибайкальского Национального Парка. Он нуждается в улучшении экотропы, которая должна быть благоустроена (с обозначением границ) для безопасного использования (с учетом крутого склона).

В ходе данной работы будет разработан совместимый с биоразнообразием экотуристический план и будет благоустроена экотропа на мысе Хобой, будут установлены смотровые платформы и информационные знаки.

Кроме того, будет создан микрорезерват на косе «Ханхойская» для сохранения популяции редкого растения *Craniospermum subvillosum* Lehm.

Это растение включено в Красную книгу Иркутской области (2010). Этот вид крайне уязвим вследствие узости экологических условий произрастания и негативного воздействия рекреационной деятельности. Невосполнимый вред популяциям черепоплодника наносится колесами автотранспорта, особенно квадроциклов, проезжающего по песчаным косам. Песчаная коса оз. Ханхой – возможно, наиболее сохранившееся местообитание реликтового вида растений, где популяции черепоплодника ещё не нанесено необратимого вреда. Предотвращение проезда по косе автотранспорта и запрет палаточных и иных стоянок в пределах популяции черепоплодника позволит создать условия для нормальной жизнедеятельности и самоподдержания численности популяции черепоплодника почтишерстистого.

#### Цели:

Необходимо выполнить следующие работы:

- Выполнить рекогносцировку экотропы на мысе Хобой и резервационной зоны на косе Ханхойская
- Разработать концепцию экотропы и совместимый с биоразнообразием план экотуризма для посещения мыса Хобой.
- Разработать план резервационной зоны на косе Ханхойская
- Установить резервационную зону на косе Ханхойская (установка барьеров для ограничения проезда транспорта и создание пешей тропы по Ханхойской косе).
- Сконструировать экотропу на мысе Хобой с деревянными смотровыми площадками.
- Разработка и производство информационных знаков для туристического маршрута с использованием стандартов публикаций ПРООН/ГЭФ (логотипы будут

предоставлены офисом проекта), макеты публикаций должны быть согласованы с офисом проекта.
